CRITERIA

Citizen of the Year nominees should have clearly demonstrated leadership and hard work in their lives, community, and workplace. Nominees must have taken action(s) to make Surry County, NC, and the local area a better place in which to live and work. Careers (past or present) of nominees should be in the areas of business, industry, and/or public service, but are not limited to these career areas. Nominees must be visionary, a leader, highly respected, and a supporter of education, the Chamber of Commerce, and the community.

Seven Categories to Consider

- 1. VISIONARY -- Able to assess external and internal forces likely to significantly influence Surry County's future, and identify actions needed to manage these forces to maximum benefit.
- 2. LEADERSHIP -- A leader not only through his/her hard work, but also through their ability to bring people together, motivate them, and achieve something great.
- 3. HIGHLY RESPECTED / ADMIRED -- One who is fair, ethical, and honest in dealings with others. One who has a likeable and friendly personality and is admired for those qualities.
- 4. STRONG SUPPORTER OF EDUCATION -- One who is involved in improving educational opportunities for all and is actively involved in one or more education initiatives with a leadership position in at least one.
- 5. AMBASSADOR For Business, Industry, and Economic Development -- Involved in efforts to increase commercial and/or economic development.

- 6. CHAMBER CONNECTION Nominee should have a track record of ongoing involvement in the Greater Mount Airy Chamber of Commerce (membership, attendance, service on a committee, etc.).
- 7. COMMUNITY INVOLVEMENT Nominee should be active in community organizations. (Non-profit organizations, Civic Club, PTA, etc.


